Terms of Business

K9 Walker will only walk dogs that:

- Have an ID tag
- Are wearing a safe collar, suitable for the size and weight of the dog. All fixed, half check/choke collars must be fitted so they do not slip over the dogs head
- Haltis and harnesses will only be used in conjunction with half check/choke or fixed collars
- Have a correctly fitted muzzle (dogs with dog to dog aggression)
- Leads are safe and suitable for the weight and size of the dog

1. K9 Walker will walk the dog(s) described above for not less than the time stated and on the times and days mentioned above from the Customers address, unless some other address is shown above. K9 Walker reserves the right to walk other dogs at the same time, unless the Customer has booked One to one dog walks, but the total number of dogs walked with one person at one time will not exceed [4].
2. K9 Walker will walk the dog(s) on other occasions by appointment.
3. Caroline Watling will provide this service either personally or by a person appointed by and working under K9 Walker's instructions.
4. The Customer will either ensure access is given to K9 Walker to collect the dog(s) from the agreed address at the agreed times or give K9 Walker a key to the place where the dog(s) is kept. K9 Walker will use the key to collect and return the dog(s) and for no other purpose and will keep it safe, not let anyone else have it, copy it and will return it to the customer on demand.
5. The Customer will supply suitable collars or harnesses and leads (and where necessary muzzles) for the dog(s) and any coats or other accessories which the Customer wishes to be used. K9 Walker will be entitled to refuse to walk the dog(s) if a suitable collar or harness and lead (and muzzle) is not provided and to be paid in full as though the walk had taken place. Also food and drink bowls, bedding, brushes and any toys.
6. No dog will be accepted unless it is following an appropriate de-flea treatment. No dog will be accepted if it arrives at K9 Walker showing signs of any sort of parasite. Dogs must arrive in a clean and well groomed condition.
7. K9 Walker's charges are at the rates and are payable at the times set out above.
8. The Customer will inform K9 Walker fully of any characteristics of the dog(s) which needs to be known for handling and care of the dog(s).
9. K9 Walker holds insurance in respect of the death, loss or injury of dogs in K9 Walker's care for a maximum of £5,000 per dog and shall have no liability to the Customer for any claim in respect of the dog(s), except such claim if any as covered by the insurance and admitted by the insurer.
10. K9 Walker will inform the Customer of any incident or anything which K9 Walker notices about the dog(s), which as dog owners the Customer ought to know.
11. K9 Walker will keep the dog(s) on a lead whenever out of the house, unless specifically authorised by the Customer, will take care so far as is practicable both that the dog(s) is not a nuisance or danger to anyone, or any other animal, and that no harm comes to it. K9 Walker will provide appropriate receptacles for the removal of dog faeces and ensure that the dog(s) does not foul any public or private place.
12. The Customer will provide K9 Walker with details of the dog(s) inoculations and contact details of its/their vet. In the case of need K9 Walker is authorised to refer the dog(s) to the named (or in an emergency any other) vet for advice or treatment at the Customers expense. The Customer undertakes to reimburse to K9 Walker all expenses incurred under this clause.
13. The Customer will provide such food and treats as will be needed by their dog(s) for the duration of the booking. In cases where the customer has not provided enough food, K9 Walker will buy sufficient food to make up the shortfall, and the Customer will be liable to reimburse K9 Walker for this expense, on the production of valid purchase receipts.
14. Either party may terminate this agreement by not less than one week's notice to the other at the address given in this agreement.
15. Please do not attempt to make a booking for a dog if it is covered by the "Dangerous Dogs Act".
